Injured Person No1 IP was required to move a bundle of various size steel box section tubes from a pair of trestles. IP used the overhead crane for this operation (Which he has received training to operate the machine to the NPORS standard). IP put the chains around the load and lifted the bundle to the new position. Once the bundle was located into the new position, IP removed the chains and made the crane safe. IP then removed a piece of Box Section from the bundle, which IP required for his work, in doing so another piece of Box Section steel, fell from the bundle, striking IP on bridge of the Left Foot, IP was sent to Hospital, IP returned stating the foot was bruised. IP will be retrained on the overhead crane, and have further Manual Handling Training and instructions to help prevent any further injuries of this nature. Care points will be issued to all members of the workforce in this area to remind them of the manual handling procedures i.e. plan the lift, is it safe to lift, before attempting any manual handling manoeuvres. Injured Person No2 IP was hammering an insert into a Ram housing to ensure of the fit. IP then struck his fingers on his left hand with the copper hammer he was using, causing bruising to the fingers and nails. IP was
